Regulations of the Accommodation proceedings "Summer period 2024"

- 1. The campaign takes place via the website https://esks.pw.edu.pl.
- 2. Only correctly completed and timely submitted electronic applications are considered in the campaign.
- 3. The deadlines for submitting applications are determined by the schedule of the accommodation campaign "Summer period 2024".
- 4. Priority for accommodation is granted to persons with the status of a student or PhD student of the WUT.
- 5. In the first instance, places will be allocated to those who are living in the WUT dormitories at the time of application consideration.
- 6. The primary consideration in allocating places is the order of application.
- 7. Payment deadlines:
 - 1. For accommodation for a period shorter than or equal to one month, payment is due in advance on the day of accommodation.
 - 2. For accommodation over one month:
 - a) persons with the status of a student or PhD student of the WUT by the 15th of each month.
 - b) persons who do not have status of a student or PhD student of the WUT by the 10th of each month.
- 8. Summer accommodation is possible from 1 July to 20 September with the following conditions:
 - 1. Persons who do not live in the WUT dormitory at the time their application is processed, but who require accommodation from 29 June and have selected this option in their application, can receive a referral from 29 June, depending on the availability of places at the time of application processing by the quartermasters..
 - 2. Persons who are not living in a WUT dormitory at the time of application processing and have not been allocated a place in accordance with point 1 they will receive referrals from 3 July at the earliest.
 - 3. Persons who do not live in the WUT dormitory at the time their application is processed, they will receive referrals from 1 July at the earliest.
- 9. In the case of accommodation from June 29 for the days June 29 and June 30, the daily payment determined by Decision No. 146/2023 of the Rector of the Warsaw University of Technology dated June 7, 2023.
- 10. For accommodation from July 1. 2024, the amount of accommodation payments is determined by Decision No. 77/2024 of the Rector of Warsaw University of Technology dated April 23, 2024.
- 11. The condition for receiving a place in the "Summer period 2024" accommodation campaign is the payment of all existing fees related to accommodation in the Student House by June 17, 2024.
- 12. The possibility of accommodation is based on a referral issued through the ESKS system.

- 13. Referrals are valid for 3 working days from the date of the beginning of accommodation due to the from the referral.
- 14. People who are applying have the opportunity to check the option "if I can't get accommodation before July 3 I resign from the place". Checking this option will result in the rejection of the application if no room is available before July 3.
- 15. Persons who applied for accommodation before July 3, 2024 and did not check the option "if I cannot get accommodation before July 3 I resign from the place", and the Student House does not have an available room, will receive a referral valid from July 3, 2024.
- 16. Persons who are accommodated in the Student House as of June 30 and remain in the same room for the summer period must report to the Student House administration by July 8 for reaccommodation for the summer period.
- 17. Persons who are accommodated in the Students House as of June 30, but have been assigned another room for the summer period must make arrangements with the administration of the Students House by June 30 to be reaccommodated for the summer period.
