Regulations of complementary accommodation proceedings for current students and PhD students 2024 - July

- 1. The campaign takes place through the https://esks.pw.edu.pl system.
- 2. Only correctly and timely completed electronic applications will be considered for the campaign.
- 3. The application deadlines are specified in the Schedule of complementary accommodation proceedings for current students and PhD students 2024 July.
- 4. The complementary accommodation proceedings are only for current WUT students and PhD students, who have the status of a student or PhD student at WUT during the verification of the application.
- 5. The allocation of places is determined according to the order of applications.
- 6. Persons who participated in the campaign for current students and PhD students 2024 and did not receive a place as a result of a low place on the ranking list shall be assigned priority in the allocation of places. This priority doesn't include those who haven't paid the reservation fee or cancelled their place.
 - a) In order to receive the priority mentioned above, the box "I did not receive a place in the accommodation campaign for current students and PhD students 2024 due to low ranking " should be ticked in the application.
 - b) The applications of those persons who untruthfully tick the box "I did not receive a place in the accommodation campaign for current students and PhD students 2024 due to low ranking" will be automatically rejected.
- 7. By submitting an application, the student/ PhD student applies only for a place in one of the WUT dormitories. Places in specific rooms will be allocated at random, by decision of the Quartermaster. Possible changes to the allocation will be possible after accommodation has been provided as part of the accommodation campaign "Bank of Places".
- 8. Submitted applications shall be formally correct, i.e. include all obligatory fields filled in and have correct data entered, in especially the address of permanent residence. If the address of the student's permanent place of residence is provided as the address of the WUT student dormitory, applications will be returned for correction for formal reasons. Failure to correct the application in this respect will result in its rejection for formal reasons.
- 9. Applications of persons who do not have the status of a WUT student or PhD student during the verification of the application will be rejected for formal reasons.
- 10. Only persons who have not been punished with disciplinary penalties during their accommodation in Warsaw University of Technology Students Houses may participate in the proceedings.
- 11. Only people who, as of July 15, will be settled with the Students Houses, that is, will not have any outstanding payments, may participate in the campaign. People who, at the time of application, are not living in dormitory, but lived there in the past must have the "settled" status. Otherwise, their applications will be rejected for formal reasons.

- 12. Those who are allocated places in one of the WUT student dormitories will have to pay a reservation fee of PLN 300 to the account number indicated in the referral.
- 13. Reservation fees of a minimum of PLN 300 must be credited before the deadlines specified in the schedule of the proceedings.
- 14. Not paying the reservation fee in the required amount and deadline is equivalent to resignation from the assigned place.
- 15. In the case of a reservation fee of more than the fixed PLN 300, the overpayment will be credited to the first months accommodation fees Certificates for allocation of accommodation will be issued only after credited of the reservation fee.
- 16. Referrals issued as part of the campaign will be valid from 27 September to 6 October 2024.
- 17. Loss of WUT student or PhD student status after a place has been allocated shall not result in the loss of the place reservation.
