

**Schedule of complementary accommodation campaign
for summer period 2025**

June 28, 2025	The beginning of submission of applications through the ESKS system.
September 14, 2025	Deadline for submission of applications.
September 19, 2025	End of accommodation campaign.
September 19, 2025	The last day on which those accommodated in the campaign for the summer period and who do not have an allocated place for the 2025/2026 academic year must check out of the dormitory.
September 23-25, 2025	Re-accommodate those who were accommodated in the campaign for the summer period and have an assigned place for the 2025/2026 academic year to the appropriate Dormitories/rooms.

Regulations of the complementary accommodation campaign for the summer period - 2025

1. The campaign takes place through the <https://esks.pw.edu.pl> system.
2. Only electronic applications that are properly completed and submitted on time will be considered in the campaign.
3. Submission deadlines are specified in the schedule complementary accommodation campaign for summer period - 2025.
4. Applications are processed within 3 working days of submission.
5. As a condition for receiving a place in the complementary accommodation campaign for the summer period – 2025 is the payment of all existing fees related to accommodation in the WUT dormitory until the application has been processed.
6. Priority for accommodation is given to those who have the status of a student or PhD student of the Warsaw University of Technology.
7. Priority will be given to those who are residents of the WUT dormitories at the time of application consideration.
8. The basic criterion for the allocation of places is the order of applications.
9. The summer period accommodation is available from July 1 to September 19, 2025. Those who do not have an allocated place for the 2025/2026 academic year must check out of the dormitory no later than September 19, 2025.
10. The amount of accommodation fees is determined by Decision No. 88/2025 of the Rector of Warsaw University of Technology dated May 12, 2025. r
11. Payment terms:
 1. In the case of accommodation for a period of less than one month, payment in advance is obligatory, on the day of check-in.
 2. In the case of accommodation for at least one month applies until the 15th of every each month.
12. The check-in process is based on a referral issued in the ESKS system.
13. The ability to check in is based on a referral issued through the ESKS system.
14. Referrals are valid for 3 working days from the start date of accommodation indicated in the referral.
15. Po otrzymaniu skierowania, w celu zakwaterowania trzeba zgłosić się do administracji danego Domu Studenckiego w dniu roboczym w godzinach 8:00 – 15:00.
16. Persons who receive places in the ZDS for at least one month will have to pay a guarantee fee at the time of check-in or, if the quartermaster decides to do so, at the time prior to check-in indicated in the referral. The payment can be made to the account number

indicated in the referral or by credit card at the administration of the dormitory where the place was received.

17. The guarantee fee for the summer period (from July 1 to September 30, 2025) is:

1. PLN 500.00 - for WUT students and PhD students, as well as students and PhD students from other universities with which Warsaw University of Technology has concluded agreements on accommodation in WUT dormitories,
2. PLN 1,000.00 - for other persons.

18. Certificates of allocation of places will be issued by the quartermasters only after the guarantee fee has been posted.
